AGENDA ITEMS:

- 1. **Welcome.** The meeting was called to order by Ms. Daigle at 8:00 a.m. The City Attorney offered clarifying procedures about opportunities for public comment at the Aviation Committee.
- 2. **Self-Introductions** were made.

- 3. The **minutes** from the September 24th, 2012 Committee meeting were approved.
- 4. Current Business All Things Aviation:
 - **Settlement Agreement Extension Update.** Kiff noted that the Settlement Agreement negotiations had continued since the last meeting, with multiple meetings. He expected that more information would be part of the public process in January 2013, and that 2013 would involve public agency votes on the Extension as well as the CEQA process.
 - **JWA Operational Updates.** Alan Murphy noted that Tom Edwards' report had covered most of the information he would have delivered, but noted that operations were up about 6.9% in October 2012 from October 2011. Edwards noted that holiday traffic was significant over the weekend.
 - RAWLZ Consensus-Building. Kiff said the City has conferred with GE Aviation twice since the last meeting to develop a scope of work that would offer a more precise departure pattern for RAWLZ, and that the City was likely to soon contract with GE Aviation to do that work. He noted that GE would work with the community as well, including the small group that had worked with Kiff on the recent RAWLZ discussions. David Browne asked that the scope ensure that over-the-coast departure routes be addressed as well, and Kiff confirmed that they would be.
 - Edwards' Monthly Report. Tom Edwards referred readers to his electronic report.
- 5. Public Comments on Non-Agenda items involved:
 - Mr. Hawkins noted his concern about the City Attorney's comments about the Brown Act.
- 6. **Items for an Upcoming Agenda.** Suggested items included other regional airport alternatives (including Ontario), discussion about further studies regarding air quality.
