Mariners' Mile Revitalization Master Plan Withdrawn

Based upon concerns expressed by the community regarding the configuration of Coast Highway, staff believes this is not the appropriate time to pursue the adoption of the Mariners' Mile Revitalization Master Plan (Plan). Therefore, staff has withdrawn the Plan from further consideration at this time. Staff anticipates that the draft Plan may be considered again following the comprehensive General Plan update, scheduled to begin in late 2017.

In 2011, the City Council designated Mariners' Mile as one of six "revitalization areas" in the City, and Mariners' Mile is the



last of these areas to be examined. The Plan was envisioned to be a consensus building process to develop a vision for future improvement in the area based on the existing General Plan. To date, a community consensus has not been realized.

Many public comments centered around the Plan to widen West Coast Highway, which is a requirement that has been in place since the 1970s and is reflected in both the General Plan and Regional Master Plan of Arterial Highways. While this topic is not part of the Plan, many commenters requested that Coast Highway needed reexamination before proceeding. With the Plan on hold, the General Plan update can comprehensively address the policy direction in respect to the widening of West Coast Highway, development density/intensity limits, and building height in Mariners' Mile.

Property Owners or Lessees May Join City's Appeal of FEMA's Flood Hazard Maps

The City of Newport Beach is preparing to appeal the proposed flood hazard determination made by the Federal Insurance Administrator of the Federal Emergency Management Agency (FEMA). The City has hired Everest Consulting International Inc. to conduct an independent scientific and technical review of the preliminary maps. Digital copies of FEMA's maps are available at: <u>http://www.fema.gov/preliminaryfloodhazarddata</u> or on the City's website at: <u>http://www.newportbeachca.gov/fema</u>

Before any new or modified flood hazard information becomes effective for floodplain management purposes, FEMA provides an opportunity for the community to appeal the proposed flood hazard information. During the appeal period, any owner or lessee of real property may appeal the determination with the City.

It is important to note that the sole basis for such an appeal is the possession of knowledge or information indicating that the proposed flood hazard determinations are scientifically or technically incorrect. By filling out a form available from the City (see link below), property owners have the opportunity to combine their appeal with the City's appeal, based on the same scientific and technical grounds the City is preparing.

STRUCTURE FIRE AT FLAGSHIP HEALTHCARE CENTER

On July 9, the Newport Beach Fire Department responded to a reported structure fire at Flagship Healthcare Center, a skilled nursing facility. After first in crews arrived and encountered smoke at the rear of the structure, the fire was escalated to a working structure fire with personnel responding from Costa Mesa and Huntington Beach Fire Departments.

Approximately 50 residents and staff evacuated, and many residents were in need of assistance to evacuate. The fire was extinguished and isolated to a storage basement. The cause of the fire is currently under investigation.


MARINE OPERATIONS DIVISION

NOTABLE EVENTS AND RESCUES



On July 10, Hoag Hospital hosted the 38th Annual Project Wipeout Lifeguard Conference, focusing on spinal awareness. This annual lecture attracts over 400 lifeguards throughout Southern California to listen to speakers discuss saving lives and preventing injuries at the beaches. Project Wipeout was founded by a group of doctors, Newport Beach lifeguards and firefighters. Lifeguard Captain George "Skeeter" Leeper was the MC for the event. EMS Division Chief Kristin Thompson and Fire Captain Phil Puhek were guest lecturers on "Care for Patients with Cervical Spine Injuries." Congratulations to Lifeguard Alex Brandt, who received the Excellence in Lifesaving Award for two rescues where he performed CPR and had positive outcomes.



RESCUES



At approximately 7:05 p.m. on July 12, off duty Seasonal Lifeguard Jeff Pratt was with his daughter on 30th Street, when he saw two swimmers caught in a rip current and struggling. Jeff sent his daughter to the shore and swam to help the swimmers while yelling for someone to contact lifeguards.

A beach goer offered to help Jeff and both were pulled out into the fast moving current. Neither Jeff nor the beach goer had fins or a buoy. After 10 minutes in the water, the beach goer grew fatigued and stated he was going to drown. Seasonal Lifeguard Carter Walton was locking up his tower when someone notified him of the incident. Carter responded to assist the group to shore. Jeff yelled for three surfers to help with their boards. All three victims made it to a board. Jeff swam back to shore to call lifeguard dispatch for backup. Jeff returned to the water to help Carter bring the victims to shore. The victims were fatigued but otherwise okay; the beach goer swallowed a lot of water and became exhausted. The beach goer was treated with oxygen and transported to Hoag Hospital.



At approximately 5:15 p.m. on July 17, Seasonal Lifeguard Kyle Lawrence (Tower 74) was alerted to trouble in the river about half way to the bridge. Kyle found a drowning victim, floating face down in the water. The victim's brother and father were unable to get the victim out of the water on their own, due to a swift current flowing from the incoming tide. Kyle pulled the victim to the riverbank, discovered that the victim was pulseless, and began CPR. A bystander offered assistance and performed mouth to mouth while Kyle did compressions. Seasonal Lifeguards Keegan Beavers and Wyatt Muller arrived and set up the AED. The AED advised for a shock and they delivered the shock. After one more cycle of CPR, the victim was responsive. Lifeguard Officer Andrew Matsuyama arrived, administered oxygen, and helped place the victim on the backboard. Newport Beach Truck 62 personnel Captain Brett Sutherland, Engineer Andy Hopper, Paramedic Bryan Carter and Jeremiah Martin arrived and worked together with lifeguards to safely get the victim over the rocks and up to the ambulance. The efforts made by fire and lifeguard personnel and the bystander, ultimately saved this victim's life.



FIRST AID

On July 17, Newport Beach Lifeguards started using the new Sting Ray Wound bags. A lifeguard truck carries these bags and an insulated cooler to hold hot water. They are able to treat on site on the beach instead of coming back to lifeguard headquarters for supplies. Patients can now stay with their families and go home when they are ready. The bag is theirs to keep. These bags also allow for lifeguards to go back in service within five minutes rather than 20 or more minutes.



JUNIOR LIFEGUARDS



On July 13, we celebrated our 37th annual Junior Lifeguard Hot Dog Dinner. Our Junior Lifeguard Instructors cooked 4,000 hot dogs for our participants and their families. The families also contributed some great desserts!



On July 17 and throughout the week, the Newport Beach Junior Lifeguards completed their pier jump from the Newport Pier. Age groups 9 to 15 participated in this annual activity. Many are nervous, and have an increased level of confidence once they jump and land in the water.







Fire Ring Relocations

Last Friday morning, Field Maintenance Division staff relocated fire rings at Corona del Mar State Beach to comply with the plan approved by the Coastal Commission. Crews utilized heavy equipment to rearrange the fire rings to their new location, and a beach cleaner cleaned the old fire ring locations.

The plan includes a total of 24 fire rings at Corona del Mar; 16 wood-burning and 8 designated for charcoal. Four of the wood-burning fire rings are designated for ADA access.

Additionally, next week we will add three fire rings to Newport Dunes, which will bring its total to eight wood-burning fire rings. In the coming weeks, new signage will be installed at the Dunes, and Balboa and Corona del Mar beaches.



Marine Avenue Tree Removal Update

At its May 2, 2017 meeting, the Parks, Beaches and Recreation Commission approved removal of two Special Trees at 318 and 326 Marine Avenue. The trees were identified as potential liabilities for failure. On Tuesday, the two Special Trees were removed by the City's tree contractor, Great Scott Tree Services.

In preparation for the removals, MOD staff worked with Traffic Engineering to develop a detour plan that allowed outbound traffic on Marine Avenue with inbound traffic using the North Bayfront alley. The detour allowed the contractor to remove the trees safely and quickly.



Restoration of Bronze Plaques

Last week, a historical bronze plaque was restored by Restoration ArTechs under the direction of City staff. The 1930's plaque came from the old Little Balboa Island Bridge before the demolition started. The contractor will reinstall the new piece before the new bridge is re-opened on July 25, 2017. The restoration process required stripping, cleaning, staining and applying a protective clear coat. Staff could not locate any documentation when the last time this bronze plaque was serviced.



Sewer Lateral Replacement

The Wastewater Crew recently replaced a sewer lateral (the pipe between the property and the sewer main) on Setting Sun Drive by pulling a High Density Polyurethane pipe while pipe bursting the existing clay pipe which had become inundated with roots at every joint. The new technology of pipe bursting and pulling new pipe is faster and more efficient than digging up the whole line and replacing it. The new pipe material will provide years of service and restrict root intrusion as compared to the old clay pipe.





Sewer Spill

Thanks to the quick response recently on Superior Ave by the Water Maintenance Crew, they were able to reduce the amount of sewage reaching the bay. Crews built a berm at a storm drain catch basin and Vacuum truck operators captured about 500 gallons of sewage that would otherwise enter the bay. The spill was caused from an overflow on private property but the City will always respond when sewage enters the streets or storm drain system. Great job!

Bayview Heights Restoration Mitigation Project Gets Approved!

After a very lengthy application process, the City's Bayview Heights erosion control project received Coastal Commission approval on July 13, 2017.

The project consists of drainage improvements, erosion repair and habitat restoration on the northern side of Upper Newport Bay (end of Mesa Dr.). Extensive erosion of this natural drainage area has resulted in a substantial amount sediment of entering Upper Newport Bay. To reduce erosion the City will install a storm drain, repair the eroded areas and perform habitat restoration.



With permits in hand, Public Works looks forward to starting another important water quality project for the community!

Bonita Canyon Sports Pickleball Courts Update

On July 11, 2016, an OxBlue camera was installed at the construction site for the Bonita Canyon Sports Park Pickleball Courts. OxBlue is a construction camera company focused on providing cameras for site monitoring and improved project delivery. This construction time-lapse camera takes images of the construction site every 10-15 minutes, allowing the project team to monitor and document the construction site. Once the project is complete, the pictures taken during construction of the pickleball courts are compiled to produce a video showing the time-lapse construction project.



Last week, the OxBlue camera captured moments during the pouring of the V-gutter drainage; installing the fence post and placing concrete forms for two of the pickleball courts. This week, the camera took pictures of the concrete pour for the first two post-tension concrete pickleball courts.

In the upcoming weeks, the fencing and two remaining post-tension pickleball courts will be installed.

Median Landscape Turf Replacement Project



Replacement Project on San Joaquin Hills Road and San Miguel Drive.

This project removes and replaces dead grass on both medians with fresh green California water friendly landscaping. Work began July 17 and will be complete by December 2017.

Balboa Pier Repairs

The wave actions from the winter storms earlier this year destroyed the lumber utilities access system and a number of pile cross braces that existed under the Ruby's Restaurant at the end of the Balboa Pier. Since access to the under-deck utilities must be maintained, the City contracted with John S. Meek Company to reconstruct the platforms, catwalks, railings, ladder, etc. as well as installing replacement pile braces.

Ocean piers construction work is a specialty trade with limited contractor availability. Meek Company answered the City's call by mobilizing their crews from their other on-going projects.



Construction Cost Inflation!

Two recent reports from the private sector indicate that strong market conditions continue to put pressure on construction costs (materials, equipment and labor). According to Turner Constructions' Second Quarter 2017 Turner Building Cost Index, <u>costs have a year over year</u> <u>increase of 4.96%</u>. Turner is ranked as the largest general contractor in the United States. Rider Levett Bucknall, a national leader in construction management, is tracking that the <u>national average construction costs have increased approximately 4.80%</u> between April 2016 and April 2017. Inflation varies in different parts of the county and low commodity prices have helped. However, over the last 6-8 months, Public Works is definitely noticing <u>construction costs are creeping up</u> and seem to be higher than the consumer price index inflation.

SENIOR TRANSPORTATION SERVICE RECEIVES GRANT FROM HOAG HOSPITAL

Staff just received great news that the OASIS Transportation program will receive a grant from the Hoag Community Benefit program for \$150,000! This is the largest grant this program has ever received! This grant will assist in the cost of providing excellent transportation service to our senior residents for FY18.

The OASIS transportation service provides approximately 15,000 rides per year for City residents age 60 and over who have retired from driving, either temporarily or permanently. Rides are provided from a resident's home to the OASIS Senior Center, medical appointments, grocery stores and any other essential errands that they may need. Transportation is available within City limits with a few exceptions to areas in Costa Mesa and Irvine. Seniors using the service report that they have a marked increase in quality of life: access to healthcare, socialization and essential services and a decrease in isolation and depression, common maladies in older adults.




NCCC RECEIVES MORE NATURAL LIGHT!
