A. Quarterly Financial Report (QFR)

The City Manager's 9/30/2011 Quarterly Business Report (QBR) is on the City Council agenda Tuesday, 11/8/2011. This is an update for Finance Committee of the financial report included within the QBR. We will discuss 6/30/2011 balances as well as first quarter projections for 9/30/2011 of the City's "Top 3" revenue sources. (10 minutes)

B. Bonita Canyon Refinancing

The Bonita Canyon Public Facilities Financing Authority is a joint venture formed by the City and the Newport-Mesa Unified School District to finance public facilities that benefit properties in the Bonita Canyon area. This is an update to Finance Committee on the intended Bonita Canyon Refinancing which will lower the reserve and achieve cash flow savings. (5 minutes)

C. Latest PERS Actuarial Valuation Reports

The City has received the latest actuarial valuation from CALPERS dated 6/30/2010. This is an update to Finance Committee of the results of that valuation. (30 minutes)

This committee is subject to the Ralph M. Brown Act.
