 a) Department Report – Chief Poster flew over Newport Beach to review the High Hazard Fire Zone map and to recommend any changes. Newport Beach Lifeguards have recently completed two Scuba Dive Trainings and are scheduled for Helicopter Training March 7, 2012.

Seasonal Lifeguard try-outs will be held March 18, 2012. There are 116 applicants at this time.

Three Junior Lifeguard Swim Tests have been completed, which consists of a 100-yard swim under a designated age-appropriate time frame, in addition to treading water for three minutes.
