The City's goal is to promote the health and wellbeing of residents of the area. Simple "good-neighbor practices" by equestrian properties, are key to accomplishing this goal.

Unique Requirements for a Unique Newport Beach Neighborhood

The Santa Ana Heights (SP-7) zone was established to provide for the orderly and balanced development of the community. As such the REQ district provides for the development and maintenance of a single-family residential neighborhood with limited equestrian uses and the RSF provides for the development and maintenance of medium density singlefamily detached residential neighborhoods with limited equestrian uses as well.

Newport Beach Municipal Code Sections 20.90.060 & 20.90.080 *Residential Equestrian Standards*

Number of Animals

- The number of horses and ponies allowed differ by district.
- Generally REQ allows:
- * One on lots < 10,000SF
- * Two on lots 10,000SF < 15,000SF
- * Three to six on lots > 15,000SF
- Generally RSF allows:
- * One to two on lots 10,000SF < 15,000SF
- additional horse or pony for each additional 10,000SF in lot size.

Dust Control

Implement methods of light watering of arenas and exercise areas or chemical dust control.

Insect & Vermin Control

- Store dry grains and pellets in rodent-proof containers.
- Store hay on raised platforms (min. 6 inch. clearance above surface area).

Waste Collection & Storage

- Store animal waste & contaminated materials (straw, shavings, etc) in a sturdy, water-tight unit.
- Provide for the daily collection of manure and in no case should manure be stored for longer than seven days. Protect storage facilities from rainfall & surface runoff.
