AGENDA ITEMS:

- 1. Welcome. The meeting was called to order by Ms. Daigle at 7:57 a.m.
- 2. **Self-Introductions** were made.
- 3. The **minutes** from the April 29th Aviation Committee meeting were approved without amendment.

4. Current Business – All Things Aviation:

- JWA Update. Mr. Murphy spoke about trends at JWA, noting that May 2013's numbers will show an increase of about 7% year-over-year, with year-to-date numbers also up 7% in terms of passengers. In response to a question, Murphy said that about half of the 7% increase was due to international travel, but that we'll see some of that likely level off in a few months given that the new international destinations came on line in June and September 2012.
- O Update on CEQA process for Settlement Agreement Amendment/Extension. Murphy said that the consultant team for the EIR is expected to be selected soon to start work in Fall 2013. Five firms responded to the RFQ. The City is a "responsible agency" within the CEQA process, not a colead agency. Mr. Mosher asked that links to the previous EIR be made on the City's website, and asked about scoping meetings associated with the EIR.
- Clarifications on Tom Edwards' Monthly Report. Edwards briefly clarified that "1,500" meant "1,500 parking spaces" in his report. Discussion ensued about the RAWLZ departure procedure, when and if it might take effect, if a committee from the community would be working on the development of the RAWLZ, and what the status is of other noted departure and arrival procedures like the DUUKEs. Eleanor Todd had a map of the STREL. Rush Hill asked about recent slight increases in CNEL at various noise monitors ("possibly due to increased operations, given that CNEL is cumulative..."). Edwards noted that nationwide, load factors (percent of seats filled) continues to rise, to 84.2%.
- O Departure Procedures Update. Kiff noted the receipt of a response from the FAA regarding RAWLZ, and that he felt positively about the FAA's apparent openness to considering a more precise Upper Bay departure path. The FAA letter suggested that use of such an RNP was something they would look at after looking at something similar at Hartsfield-Jackson airport in Atlanta, GA. The earliest they'd look at it for JWA was "mid-2014." In the meantime, Kiff said that he and Edwards would confer with GE Aviation on next steps for our proposal. Kiff said he would place the FAA letter on the City's website.
- 5. **Public Comments on Non-Agenda items**. Mr. Mosher noted Air Fair's concern with recent comments by Mr. Gary Sherwin in regards to seeking a DC-JWA connection. Hill clarified the relationship of Newport Beach and Company to the City and Visit Newport Beach.
- 6. **Items for an Upcoming Agenda.** None were suggested.
- 7. **The Committee's next meeting** was set for 8:00 a.m. on Monday, July 29th, 2013 in the Civic Center Community Room (*NOTE: There was no meeting in July nor August 2013*).
- 8. The meeting was adjourned at 8:23 a.m.
