Dear Potential Contract Instructor:

Thank you for your interest in being a Contract Instructor for the City of Newport Beach Recreation and Senior Services Department. Attached you will find a Contract Instructor Application. Applications need to be submitted six to eight months prior to the desired session (however: summer classes are reviewed in October). Once your application has been reviewed, you will be contacted regarding its status.

What is a Contract Instructor?

A Contract Instructor is an Independent Contractor for the City, not an employee. A Contract Instructor signs a contract with the City to provide classes as described in your proposal. Instructors do not rent our facilities, however a portion of the fees collected are retained by the City to cover facility usage, registration, administration and promotion of your class in the Newport Navigator.

Important Information:

- The City pays the Contractor a percentage of the total enrollment fees collected, minus a \$5 per person administration fee and non-resident fees. For example, if your class fee is \$65, \$5 is deducted and then the Contractor receives a percentage of \$60. Exceptions apply to After Class Enrichment (A.C.E.) programs held at school sites.
- Advertising is provided through the City’s quarterly brochure, the Newport Navigator, which is distributed to all Newport Beach residents. Any additional advertising is the responsibility of the Contractor. Prior to distribution, Recreation Services must approve all promotional pieces.
- The City charges non-resident fees for classes and camps. This fee is not included in the instructor payment, but it is important that you be aware of it.

Non-resident fee for Classes

\$5/ class \$74 & below
 \$10/class \$75 & up

Non-resident fee for Camps

\$10/camp \$124 & below
 \$20/camp \$125 & up

- The City requires a minimum \$1,000,000 liability insurance coverage for classes that include a certain level of risk to the City. The policy must name the City of Newport Beach as an additional insured with an endorsement letter attached. The City can expedite obtaining insurance through Driver-Alliant. Please call if you’d like a quote. You may elect to use SCMAFT insurance. SCMAFT insurance is billed at \$2 per participant.
- All contract instructors must obtain a City of Newport Beach business license.
- All Instructors/substitutes/aides and assistants teaching classes to children under the age of 18 must be fingerprinted. Fingerprinting can be arranged by filling out the Exhibit A form & contacting the Recreation office.
