**D. Tree Reforestation Request - Westcliff Park/behind 1046 Westwind Way**Staff recommends that the Parks, Beaches and Recreation (PB&R) Commission approve the trees removal request of a grouping of City Brazilian Pepper trees at Westcliff Park, behind 1046 Westwind Way. The applicant has met the procedural

requirements for reforestation established in City Council Policy G-1. If approved by the Commission, there will be a one-for-one replacement Toyon trees installed at the applicant's cost.

Laura Curran commented that she was in support of the proposed tree replacement species.

<u>Motion by Commissioner Howald</u>, seconded by Commissioner Archer, to approve V. CONSENT CALENDAR. The motion carried by unanimous vote.

#### VI. CURRENT BUSINESS

#### A. Special Tree Removal Request- 2207 Waterfront Drive

Staff recommends that the Parks, Beaches and Recreation Commission approve the tree removal request of a Special California Pepper tree located at 2207 Waterfront Drive. The Special Tree meets the criteria for removal referenced in the G-1 Policy. If approved by the Commission, there will be a one-for-one replacement California Pepper tree installed at the same location.

Superintendent Pekar announced that due to several fungal conks, a large cavity, dead limbs, and evidence of declining health the tree needed to be removed. The tree was to be replaced with a 48-inch box California Pepper tree.

Commissioner Archer noted that the tree looked healthy due to its growing leaves. Superintendent Pekar commented that is normal, but the tree had internal decay, evidenced by the fungal conks.

#### Chair Granoff opened the public comment.

Jim Mosher questioned if the dollar estimation stated in the Tree Report was accurate.

#### Chair Granoff closed the public comment.

Superintendent Pekar answered questions from the Commission and confirmed that proper notification of the tree removal had been completed.

<u>Motion by Commissioner Hayes</u>, seconded by Commissioner Malouf to approve the tree removal request of a Special California Pepper tree located at 2207 Waterfront Drive. The Special Tree meets the criteria for removal referenced in the G-1 Policy. There will be a one-for-one replacement California Pepper tree installed at the same location. The motion carried by unanimous vote.

### B. Southern California Edison Presentation- Hazard Tree Mitigation Program

Presentation by John Nelson

Arborist Nelson announced that the new standard by Southern California Edison (SCE) was to achieve 12-feet clearance of tree limbs in all directions of distribution lines.

Removal may be necessary in order to resolve ongoing issues with problem trees. He summarized the criteria that was used to decide if a tree was considered a problem tree and that the City was responsible for planting trees (supplied by SCE) and maintaining the City's inventory if a tree was removed. He concluded by saying that staff had located a test site, that 53 problem trees were identified on the test site and if approved, work to remove and replace those trees was to start shortly.

Chair Granoff asked if problem trees were going to be brought before the Commission for approval on a case by case basis. Arborist Nelson answered that if there was a conflict with the G-1 Policy, then it would be brought before the Commission. The public would be notified if large areas of trees where to be removed.

#### Chair Granoff opened the public comment.

Louis Stavale lives next to the test site in the condominiums and confirmed removing 53 trees would cause visual blight to the area. Superintendent Pekar announced that the intent was not to remove trees close to the condominiums.

#### **Chair Granoff closed the public comment.**

Chair Granoff suggested that City staff meet with the homeowner's association and discuss undergrounding utility lines to save the trees. Commissioner Howald wanted to receive a follow up of how the meeting with the homeowner's association went.

Commissioner Howald commented that if Southern California Edison agreed to underground the utility lines, they should also consider undergrounding the lines along 5<sup>th</sup> Avenue in Corona Del Mar. A representative from Edison announced that Edison was not looking to underground utilities in the area.

David Gonzalez, Southern California Edison, noted that the trees on the test site are considered invasive trees, they would need to be addressed at some point, and Edison was willing to investigate faster-growing replacement trees.

Director Martin updated the Commission on the Marine Avenue testing process and testing was to start on March 16, 2020. A presentation and recommendations are going to be brought to the Commission once testing is done.

Director Detweiler summarized the Newport Island ribbon-cutting event, the Spirit Run, Camp Newport registration was open for discounted registration until May 4<sup>th</sup>, 2020, the program THIN had kicked off and had a successful registration process, the Mayor's Egg Roll was to take place April 4<sup>th</sup>, 2020, and March 27<sup>th</sup>, 2020 was the track meet at Newport Harbor High School. She concluded with information regarding voting and where voting stations and drop boxes were located.

Chair Granoff acknowledged Commissioner Hayes for his involvement in community events. Commissioner Hayes acknowledged Commissioner Daruty for her involvement in the Spirit Run as well as Commissioner Malouf.

Jim Mosher brought to the Commission's attention that the school district was removing trees in the City's parkway along Cliff Drive. Regarding the RHNA allocation, he quoted the Park Land Standard stating that 5 acres of new parkland were required for every 1,000 new persons added to the City.

Commissioner Howald wanted updates regarding the housing allocation and the Park Land Standard.

Superintendent Pekar summarized that the School District has said that no City trees were proposed for removal at Ensign in order to upgrade the existing parking lot and install a new security fence. Commissioner Malouf announced that there was to be a community meeting on March 16<sup>th</sup> at Ensign at 6:00 pm.

Laura Curran was impressed with the new voting system. She thanked the staff for pruning a tree outside of her home and she was excited about Big Canyon's restoration. On April 22<sup>nd</sup>, 2020 the annual Corona Del Mar Residence Association meeting was going to be held with the main topic being the RHNA Program.

#### Bayside Drive Benches and Trash Cans - Updated Look

Public Works recently replaced eight Rubbermaid trash cans and two benches on Bayside Drive between Coast Highway and Jamboree Road. The new benches and cans have the look and feel of natural wood grain, are made from 100% premium recycled material that require very little maintenance, and have a life span of up to 50 years.



#### Root for change

Early in March, before the Stay at Home Order, our Landscape staff and crew partnered with Stanbridge University for another tree-planting event at Castaways Park. Sixty-five volunteers from the University and City Staff planted 92 native trees, and 130 native plants that were donated by

Shadetree Nursery. *Root for Change* is one of Stanbridge University 's initiatives to help the environment through partnership opportunities by planting trees in locations across Southern California.

Stanbridge University 's commitment to *Root for Change* and their community outREACH will bring them back to Newport Beach in the future.

#### Grunion Season is Here!

Grunion are still coming ashore, but the California Department of Fish and Wildlife has temporarily taken the schedule down to discourage people from congregating on the beaches.

California grunion come ashore to spawn from March through August at the time of the nightly high tides and within a couple of hours afterwards. They surf the waves onto sandy beaches during full and new moons, where they bury and fertilze eggs in the sand. They ride the next set of waves back out to sea.

Grunion season presents our Beach Maintenance Crew with the opportunity to clean the beaches manually, not utilizing machinery below the tideline where the Grunion lay their eggs. Large debris like poles, logs, and plywood that wash up onshore from the Santa Ana River and San Diego Creek are picked up.

#### City Hosted Irrigation Controller Seminar

In February, before the *Stay at Home Order*, our Parks Maintenance Division hosted a central weather-based irrigation controller seminar at the Marina Park Community Center. Weather-based controllers use real time local weather data to create irrigation programs. Presenters were Rain Master Control Systems and Site One Landscape Supply. Their presentations included: review of software system navigation and tools, irrigation program creation, management, global features, micro-climate management and rain shutdown features, among other advanced management tool and software updates. The City currently has 280 central irrigation controllers, with four weather stations and repeaters. Due to this infrastructure and the training of our staff, the City has seen significant water costs savings of an approximate of \$100,000 in the past fiscal year. Additionally, this new controller technology allows access remotely and can detect breaks in an irrigation system, reducing time in trouble shooting needed repairs. As water conservation continues to be a priority throughout the southland, trainings such as this are invaluable. Special thanks go out to Maintenance and Operations Specialist Tom Diaz for coordinating this event.


#### Marguerite Avenue Palm Tree Work

Early in March, Great Scott Tree Service began trimming, spading, and inspecting the 78 Canary Island Date Palm trees on Marguerite Avenue in Corona del Mar. The spading included removal of the loose spent palm frond bases below the head of the palms. Inspection activities included sounding the trunks of the Palms in order to detect potential defects of internal decay. The crew competed the work one block a day, started with the 700 block working towards the ocean. No

parking signs were placed for the pruning days, and the community's patience of this maintenance work was appreciated.

#### New Landscape at Westcliff Park

Recently, the Landscape Division completed an enhancement project of parking lot planters at Westcliff Park. The project replaced plants that were generally overgrown and outdated. Three large Dragon Trees were repurposed from another City landscape under renovation and are surrounded by eye-popping, "California-Friendly" Gold Lantana (see attached photos).





#### Special Tree Removals

During an inspection at the Balboa Library and Fire Station, it was determined that the Special Canary Island Date Palm has died and meets the criteria for removal referenced in the G-1 Policy. It is suspected that the Palm succumbed due to a fungal infection (Fusarium oxysporum). Staff is scheduling an emergency removal of the Special Date Palm and is proposing to replace the Date Palm with a Mediterranean Fan Palm (Chamaerops humilis) from City inventory at the Bonita Canyon Reservoir.



A Special Kaffirboom Coral Tree was observed to be suffering from

significant white rot during an inspection at 2400 Margaret Drive.

As a result, the rot has weakened the structure of the tree. A Level 3 Tree Risk Assessment was conducted by a

Consulting Arborist contractor with a recommendation to remove the ailing tree. The tree's risk to the public meets the criteria for removal referenced in the G-1 Policy. Staff is scheduling an emergency removal of the Special Kaffirboom Coral tree and is proposing to replace the Special Kaffirboom Coral Tree with another Kaffirboom Coral Tree (Erythrina caffra).





#### Newport Coast - Canary Island Palm Replacements

Last year, staff discovered several of the Canary Island Palm trees on Newport Coast Drive near the intersection of Ocean Ridge to be in decline as a result of a wilt disease. The wilt disease, also known as Fusarium, is lethal in nearly 100% of infected trees and there is no chemical treatment to prevent or eradicate this pathogen.

Last week, the Newport Coast Community Association made preparations for the removal and replacement of their Canary Island Palms. Workers dug around all of the palms to be removed in preparation for the crane work necessary to remove the large and heavy palms. This week, the crane was at the work site, and due to the location of the work and the size of the crane, extensive traffic control was necessary.

Work plans call for the removal of 11 dying/infected Phoenix canariensis. In their place, 11 Date Palms (Phoenix dactylifera) will be planted, which is a species less prone to Fusarium infection.

Finally, all of the irrigation and landscape that is impacted by this extensive work will be replaced.

#### Median Renovation

The Parks Division continues with the process of renewing and renovating medians throughout the City. Recently, a median on Jamboree Road, adjacent to the newly-opened Uptown Newport development, was retrofitted with water efficient irrigation and enhanced with new plant material. The plant material matches adjoining median sections.



The project was conducted by City Staff in coordination with the City's landscape contractor, Park West, who provided the plant material. Additionally, Great Scott installed the Pindo Palm trees. Kudos to City Staff members Harold Link, William Leutbecher and Terry Williams for the successful completion of a project of this magnitude. The new landscape is sure to be visually appealing to passing traffic for years to come!

#### Coral Tree Trunk Failure





Operations staff recently found a multi-trunk City Coral tree located at 801 Bayside Drive that had one trunk fail. Upon inspection, it was determined that the failed trunk could be removed and the rest of the tree trunks stay in tact. Great Scott Tree Services (GSTS) removed the failed trunk back to the ground. To prevent occurrences, the City prunes all Citywide Coral trees annually.

#### Trees Maintenance

The City tree maintenance contractor Great Scott Tree Service trimmed trees in the Fashion Island, Corona Del Mar, Broadmoor, Harbor View Hills and Newport Ridge and Coast areas. In addition, Great Scott and staff responded to tree-related emergencies.

#### **RECOMMENDATION:**

Staff recommends that Parks, Beaches and Recreation Commission approve the reforestation request of two City Coral trees located below 2815 Ebbtide Road (on Pebble Drive). The applicant, Alan Oleson (of 2821 Ebbtide Road), has met the procedural requirements for reforestation established in City Council Policy G-1. If approved by the Commission, there will be a one-for-one replacement tree, two (2) 36-inch box *Magnolia grandiflora "Little Gem"* installed at the applicant's cost.

#### **DISCUSSION:**

The applicant, Alan Oleson at 2821 Ebbtide Road requested the removal of two Coral (*Erythrina caffra*) trees located below 2815 Ebbtide Road due to a view encroachment. The applicant states that the Coral trees have grown to such a size that accepted trimming practices (BMPs) were unable to preserve the applicant's view. A field inspecton of the trees determined that the Coral trees are in good condition and do not meet the criteria for removal referenced in the G-1 Policy. Staff denied the removal request of the Coral trees and advised Mr. Oleson of the reforestation process. Mr. Oleson requested the Board of Directors of the Harbor View Hills Community Association to review and discuss his request. The Board approved the request and provided a resolution letter to the City. The applicant met the procedural requirements set forth in the G-1 Policy.





### Magnolia grandiflora 'Little Gem'

This cultivar of Southern Magnolia has a compact, upright growth habit more typical of a multi-stemmed shrub than a single-trunked tree. It grows at a slow rate to a height of perhaps 30 to 35 feet with an 8 to 12-foot spread and flowers at two or three years old. It is surprising to see a Magnolia flower when it is only three or four feet tall. `Little Gem' Southern Magnolia forms a dense, dark green oval or pyramidal shape, making it suited for screen or hedge planting.




