2020 IN REVIEW Chief's Message

Two thousand twenty was a year of challenges, setbacks, and extraordinary efforts in the face of a pandemic. Beach closures placed our lifeguards at the center of a passionate debate during the pandemic. A swell of community support saved the 2020 Junior Guard program. Record heat and crowds in the fall pushed lifeguard activity to historic highs. As the year closed, our lifeguards helped staff one of the first public COVID-19 vaccination clinics in the county.

In the early stages of the COVID-19 outbreak, our lifeguards showed themselves to be adaptable, resourceful, and resilient. Our lifeguards staffed our City's Emergency Operations center for almost two months assisting in operations, planning, support, and logistics. We trained 33 rookies and 200 returning lifeguards by adding classes, reducing class sizes and using online training.

Newport's beaches became a gathering point under the initial "Stay at Home Order" as other recreational outlets closed or were limited. The conflict between the Stay at Home Order and the desire to be on the beach peaked in late April, captured in one picture (below) -- a crowded beach during a pandemic. The photo set off a debate about beach access and Newport Beach became the focus of national and international press. When this notoriety led to beach closures, our lifeguards demonstrated safety, service, and professionalism under intense scrutiny and pressure. People, on all sides of the issue, subjected our lifeguards to criticism and outbursts of frustration. Our lifeguards acted with a level of professionalism that reflected well on our department and profession.

As the spring progressed, we were in doubt about the feasibility of running our Junior Lifeguard program. We moved forward with our 37th season, thanks to overwhelming support from our JG families, the City Council, and the City leadership. Our JG staff put together a plan to run the program in three locations with enhanced safety protocols. The program was a success and one of the highlights of the year. We are finalizing plans for a new Junior Lifeguard headquarters, with official approval coming in early 2021.

The summer season started with cool weather and small surf. The exception was the 4th of July Weekend when we had 10-15 ft surf from the south. July 3rd was the busiest day of the summer (*see p 5*). The expected holiday crowds and an outbreak of COVID-19 among a group of our lifeguards prompted the City leadership to close our beaches for the holiday weekend to align with other OC beach closures. September and October brought record heat and crowds. The weather, telecommuting, and online schooling fueled summer-like beach crowds past Halloween. These conditions resulted in a 12% increase in lifeguard call volume, compared with our five-year average.

The year ended with our seasonal lifeguard staff providing support for the vaccinations of health care workers, public safety, and the public 65 and older. In 2019, I gave a talk at a Lifeguard seminar, describing the effectiveness of lifeguards in a disaster response, based on the skills they use every day on the beach. Watching lifeguards from across the county working together to support the delivery of over 10,000 vaccinations (so far) is one of the proudest moments of my career.

I admire the level of adaptability, service, and professionalism our lifeguards brought to our community in a year of trials, hurdles, and hardships. While 2020 was a terrible year for many, I am so proud of the efforts and achievements of the Newport Beach Lifeguards and consider myself fortunate to be in their ranks.

7/3/20 - A DAY TO REMEMBER

n July 3, 2020, the swell of the season rolled into Newport Beach. A longperiod southern-hemisphere swell hit with 10-15 foot waves. A crowd of 85,000 was exceptional for a Friday, in anticipation of the beach closures scheduled for the holiday weekend. Newport lifeguards made 2,700 preventative actions and 101 ocean rescues on the 3rd, but one ocean rescue stood out.


Lifeguard Sean Richards made a rescue, bringing a swimmer through the Balboa pier. After exiting the water, he spotted another swimmer getting swept down the beach by the 10-foot surf. When Sean brought the second swimmer through the pilings, both victim and rescuer ricocheted off the pier. He completed the save, handing off the victim to his back-up lifeguards. Exhausted by two harrowing rescues and a beating by the surf and pier, Sean collapsed on the beach. He was transported to the hospital and held for observation for several hours. Sean recovered but was battered and bruised for the next few days. Coming so close to the July 6th anniversary of Ben Carlson's last rescue, we breathed a collective sigh of relief, knowing that we were lucky that this turned out with everyone OK.

The Newport Beach City Council commended Sean for "Courageous actions performed during hazardous ocean conditions that saved two lives". Sean was also recognized by the California and United States Surf Lifesaving Associations for his heroic act.


As evening fell on the third, the surf continued to build and created flooding on the Balboa peninsula, with waves rolling over the beach and across Balboa Blvd and reaching the bay. The flooding blocked traffic, submerged vehicles, and caused some damage to the Junior Lifeguard headquarters.

The day continued to deliver havoc when lifeguards received a report of a 50-foot sailboat run aground on the peninsula after dark. When lifeguards arrived on the scene, the passengers had safely made it to shore. Lifeguards scrapped their initial plan to rescue the boat after deeming it too dangerous, as waves began breaking over the hull. Within ten minutes of arriving on the scene, the hull cracked. Five minutes later, the boat completely disintegrated in the pounding surf. Several days later, lifeguards aided a salvage company and City Public Works crews in recovering the boat's mast and keel more than a mile up the beach.

On the following day, Newport's beaches were officially closed. The crowds and activity were light. As the rest of the summer passed, the Pacific Ocean lived up to its name. There were no other large swells or busy days that came close to July 3.



As a lifeguard, we hear stories of the "big days" and massive swells. When working on one of these epic days, we realize why lifeguards love what we do. It's the teamwork, skill, danger, and bravery that create lifelong camaraderie among lifeguards. We recognize our higher purpose on those days. We grow to understand and personify the slogan **"Lifeguards for Life."** -Mike Halphide





2020 Total Lifeguard Patrol Hours




% of 2020 patrol hours by division

Nighttime Call Out Response




VISITATION 8,261,050 Estimated 2020 Beach Attendance

Average Newport Beach Pier daytime air temperature by week




3 °**F** August 21 & 23, 2020: warmest recorded surface water temperature in Newport Beach (records started in 1924).







Percent of aquatic prevention by area











Rescues by month


