## Beach Cleanup Registration FAQ's

- 1. I am an organization/non-profit/resident/non-resident ("Applicant") interested in leading a beach cleanup, what is required?**

Please complete the Beach Cleanup/Activity Registration Form and email it to [NBclean@newportbeachca.gov](mailto:NBclean@newportbeachca.gov). Please note this is a registration form and not a permit. You may contact City of Newport Beach Public Works Department at 949-644-3311 with any questions.

- 2. Do I choose the location or is that chosen for me?**

A location request can be added to the registration form; however, approval is subject to availability and is not guaranteed. If you would prefer a location be chosen for you, staff will advise based on the day/time/group size/need.

- 3. Do I assign the Registration # on the Beach Cleanup/Activity Registration Form?**

A registration number will be assigned by City of Newport Beach staff.

- 4. Is parking provided for the volunteers?**

No, regular parking rates apply.

- 5. Is there a minimum or maximum number of volunteers?**

Groups of all sizes are welcome!

- 6. Where do we leave the trash once we are done?**

Trash can be left in or by an existing trash can on the beach for pickup by the City. If it's a large group, staff will coordinate with the applicant on the details.

**7. Does the City provide gloves, trash bags, litter pickers, or any supplies?**

Applicants are responsible for providing cleanup supplies. Re-usable bags and gloves are encouraged (ex. buckets, garden gloves, old grocery bags).

**8. Can we rent out the entire beach or a section of beach for cleanup participants?**

Exclusive use of the ocean or beach is not permitted. If you are interested in a Special Event Permit, please contact the City's special event permit coordinator at 949-644-3151.

**9. Can we post advertisement signs at the beach during the cleanup?**

Set-up of banners or sponsor signage is not allowed.

**10. Can we set up a cleanup station on the sand?**

Yes, two or less 10x10 or smaller EZ-Up's or other shade equipment are permitted.

**11. Can we bring speakers/microphones/band/other amplified music?**

Use of any amplified sound is not permitted.

**12. Can we bring our own set-up vehicles for the event on to the beach?**

Vehicles are not allowed on the beach, all set-up vehicles must remain in the parking lot.

**13. Can we provide food and drinks for participants?**

Yes, however no alcohol or glass containers permitted.

**14. Can we sell organization t-shirts and other products?**

Selling of any merchandise is not allowed on the beach.
