**VII. CURRENT BUSINESS**

**A. Special Trees Replacement/Removal Request - 1701/1715 Starlight Circle and 1806 Glenwood Lane (Special City Trees)**

Staff recommends that the Parks, Beaches, and Recreation (PB&R) Commission approve the removal and replacement request of the Special City Lemon-Scented Gum Eucalyptus trees (*Corymbia citriodora*) located at 1701, 1715 Starlight Circle and 1806 Glenwood Lane, respectively. Staff's request meets the procedural requirements for reforestation established in Section IV. A of City Council Policy G-1 - *Retention, Removal, and Maintenance of City Trees* (G-1 Policy). If approved by the PB&R Commission, there will be a one-for-one replacement tree, 36-inch box, Australian Willow (*Geijera parviflora*) installed at the City's cost.

**B. Special Tree Replacement/Removal Request - 1601 Mariners Drive (Special City Tree)**

Staff recommends the Parks, Beaches, and Recreation (PB&R) Commission consider the removal and replacement request of the Special City Jacaranda tree (*Jacaranda mimosifolia*) located at 1601 Mariners Drive. The applicant, Sean McEachern, has met the procedural requirements for reforestation established in Section IV. A of City Council Policy G-1 - *Retention, Removal, and Maintenance of City Trees* (G-1 Policy). If approved by the PB&R Commission, there will be a one-for-one replacement tree, 48-inch box, Jacaranda tree (*Jacaranda mimosifolia*) installed at the applicant's cost.
