

Construction Project with Minimal Traffic Impacts




Major Project with Road Closures / Detours



Bay Crossing Water Transmission Main and Sewer Force Main Rehabilitation

Contract No. 8487-3

Dear Resident:

The City has awarded a construction contract to TE Roberts to line the water transmission main and two sewer force mains that cross under Newport Bay. Work will be performed at the vaults on each side of the crossings and includes replacing the pipeline to the manhole. The Contractor is scheduled to start on September 29, 2025, and complete by the end of November 2025. Please refer to the reverse side for a map of the general work area and approximate dates of construction.


Traffic restrictions at and adjacent to the work locations will be required on days that work is to be performed. Please comply with the posted "No Parking, Tow-Away" signs, as vehicles parked within the posted area will be towed away on working days. Normal working hours are limited to 7:00 AM to 4:30 PM, Monday through Friday.

Dear Business Owner:

The City's contractor is scheduled to begin construction in the alley and street adjacent to your property. In order α facilitate construction, the alley (as shown on the reverse side) will be closed on the dates noted below:

9/4/2025 to 10/17/2025

The scope of work includes, sawcutting and removal of existing pavement, trench shoring, dewatering, installing vaults, underground utility main line conduits and services, pull boxes, hand holes, backfilling trench and temporar pavement replacement.

Please comply with the posted "No Parking, Tow-Away" signs as vehicles parked within the posted area will be towed away on work days. We request that you observe these restrictions and any other traffic controls in the area. No-Parking / Street Sweeping signs (as per Parking Plan on reverse side) will be bagged to allow for more on street parking for the duration of this construction. Note that once construction in your alley has been completed and the alleyway has been re opened for your use, bags covering the No-Parking signs that front your street will be removed, street sweeping wil continue its regular schedule and parking will be enforced. Vehicles parked in the designated "Marine Avenue Overnigh Parking" area will have to be moved by 9:00 A.M.


Trash pickup will continue on its normal schedule. The contractor will be responsible for coordinating trash pick-up witl the City's Refuse Division and can assist in carrying your trash cans to the streets for pickup. In order to facilitate thi process, we are asking residents to write their address on each trash can. **Trash receptacles must be placed outside no later than 7:00 AM for pick up.** Please note that larger commercial type dumpsters will be relocated to designated "Dumpster Area Only" areas per the Parking Plan.
