



Description of Nature, Purpose and Beneficiaries of Project: The City of Newport Beach Council Policy K-4 was adopted in response to the need for reducing the barriers to the creation of housing to accommodate growth identified by the 6th cycle Regional Housing Needs Allocation (RHNA) including new and flexible land use and zoning regulations and strategies in order to reasonably and practicably accommodate the ambitious State housing mandate. The Director's Determination implements Council Policy K-4 and is necessary to interpret ambiguities in Title 20 Planning and Zoning Code (Zoning Code) and Title 21 Local Coastal Program Implementation Plan (LCP IP). The Directors Determination would allow hotels located outside of the Coastal Commission Appeal Jurisdiction to convert up to 30% of their approved hotel rooms into residential units on a one-for-one basis subject to existing review processed of the Newport Beach Municipal Code; accessory residential units may be located within a converted hotel room or a new residential structure. Residential units are deemed an accessory use to the principal use of a hotel and are consistent with the underlying General Plan, Coastal Land Use Plan, and zoning designations.

Reasons why project is exempt: The City Council determined that the Director's Determination is not subject to the California Environmental Quality Act pursuant to Section 21065 of the California Public Resources Code ("CEQA") and Sections 15060 (c)(2), 15060 (c)(3), and 15378 of the California Code of Regulations Title 14, Division 6, Chapter 3 ("CEQA Guidelines"). The Director's Determination is also exempt pursuant to CEQA Guidelines Section 15061(b)(3), the general rule that CEQA applies only when there is the potential for causing a significant effect on the environment. While this Director's Determination would result in an interpretation that allows residential uses as an accessory use to resort hotels, it does not authorize new development that would directly result in physical change to the environment.
