Class 1 consists of the operation, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination.

The proposed project involves interior improvements to an existing tenant space formerly occupied by a beauty salon to a health and fitness facility with accessory retail sales and represents a negligible expansion of use.

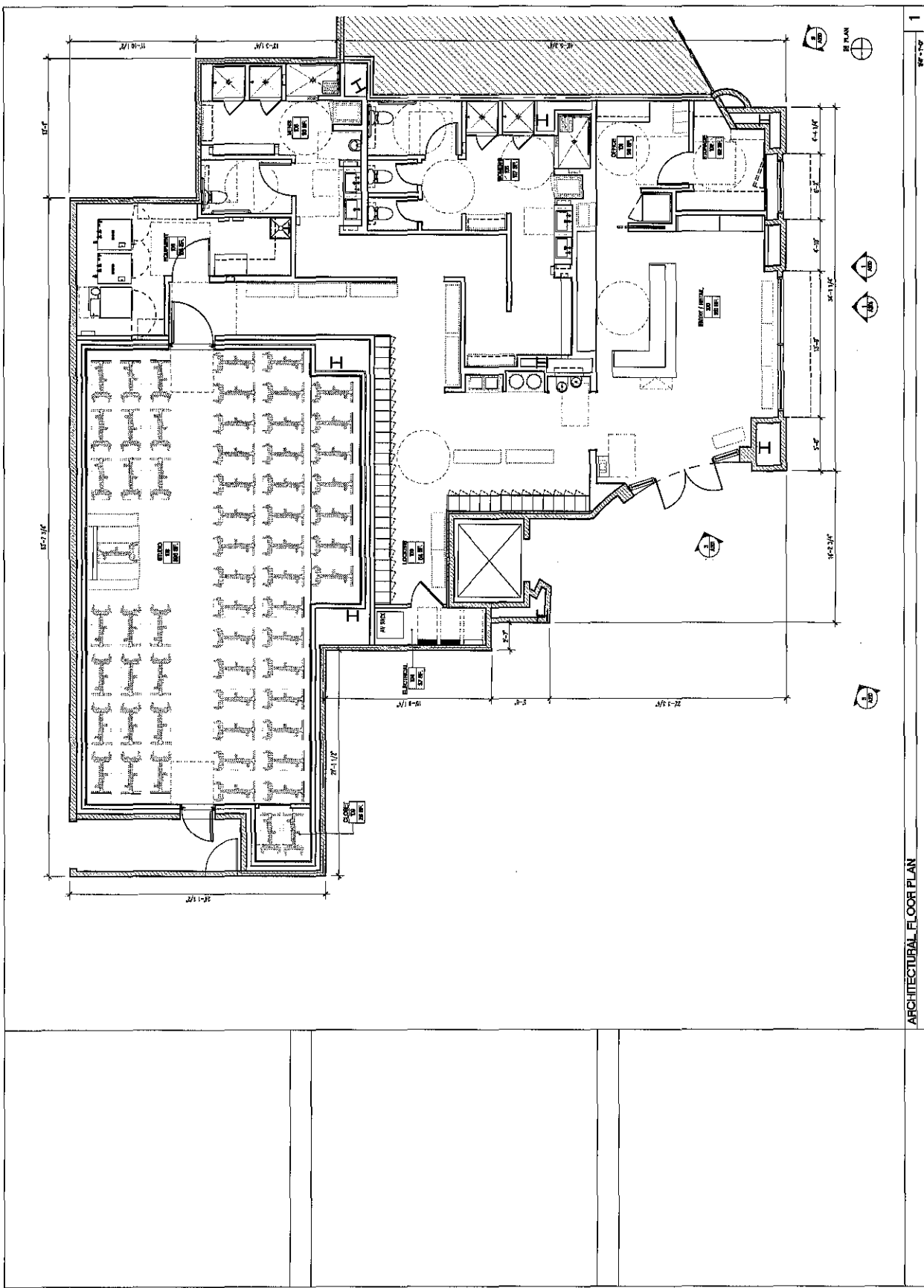
