Project Location – Specific: Bonita Canyon Sports Park is located at 1990 Ford Road which is at the south east corner of MacArthur Boulevard and Bonita Canyon Drive.

Project Location – City: Newport Beach **Project Location – County:** Orange

Description of Nature, Purpose and Beneficiaries of Project: The project includes the construction of four Pickleball courts at Bonita Canyon Sports Park West. The court dimensions would be consistent with USAPA guidelines and include 10-foot high perimeter fencing and windscreening. Other improvements include benches for viewing, trash receptacles, and a future shade element. Water efficient landscaping would be irrigated with existing recycled water and would border the courts. Existing amenities, including parking, restrooms, drinking fountains are sufficient to meet the needs of the players. A noise assessment conducted by the City concluded the noise generated by Pickleball courts would be within the City's sound limits and would be largely inaudible at the residents located approximately 300 feet from the project site.
